## **NOTICE**

It is compulsory for all the students to submit (1) ANTI RAGGING UNDERTAKING and (2) STUDENT'S UNDERTAKING (for College rules and regulations). The details and procedure are as under:

### **(1) ANTI RAGGING UNDERTAKING:**

This is made compulsory by the Hon'ble Supreme Court & UGC/AICTE Regulations that all students must fill in an ANTI RAGGING UNDERTAKING each year. To make the process easy MHRD (Ministry of Human Resource Development – Govt.of India) has developed an ONLINE facility. This undertaking is to be filled ONLINE by logging on any one of the website (1) [www.amanmovement.org](http://www.amanmovement.org) OR (2) [www.antiragging.in](http://www.antiragging.in). The procedure is very simple.

Before logging on the website the students must have his own email ID. So first create your email ID. Please note that the name of our College should be written as “Bhavan's Sheth R.A.College of Science, Ahmedabad”. Also keep your mobile number, your guardian's mobile no. since these are to be filled up in the form on website.

On successful registration, the student will get a copy of his undertaking on his/her email ID. In turn, the student has to take out its print and submit its copy to the College.

### **(2) COLLEGE STUDENTS' UNDERTAKING:**

A copy of the form of 'Undertaking' is placed on our College website [www.bhavansrasc.org](http://www.bhavansrasc.org). in both English and Gujarati languages. So log on to this college website and take out its printout – either in Gujarati or English. The students and his guardian have to fill up details in it and both have to sign the undertaking.

Both these undertakings should be submitted to Sri Babubhai P.Leuva (Laboratory Assistant) in Physics Department along with a Xerox copy each of yours'
